# New Year, New Pavillion!

Pool Complex Gets an Upgrade to start the 2019 Season!

If you haven't noticed by now, there are big changes happening at the pool complex. The Association contracted with T & D of Tallahassee to construct an open air pavilion to cover the former picnic patio portion of the complex. The structure will include ceiling fans and lighting and be constructed to match the adjacent pool house. All fences within the interior of the complex are being removed and there will be direct access to the pool. The pavilion will have chaise lounges and tables, providing parents the ability to look after their children in a sun-free environment and still be close to the pool. This major capital improvement project is slated to be completed prior to 2019 pool season opening. The pavilion will improve the pool experience for our residents and make the complex more attractive to prospective homeowners looking for a great neighborhood The pool (and the pavilion!) will open the 2019 season on Saturday, March 16th, just in time for Leon County school spring break!

Volunteers will be cleaning, scrubbing, painting, planting grass, flowers and trimming trees. The cleaning and replanting of the area will help to make the pool area a much nicer place for all our residents.

If you're new to the neighborhood and have not yet received your pool fob, this is your chance to sign for and receive your key to the fun. Please note that your 2019 dues must have be paid in order to receive your fob. The pool complex is our neighborhood's greatest asset, bringing neighbors together who would probably never meet. # **Board Meeting Highlights** 1/21/19

The first Board of Directors meeting of 2019 was held Monday, January 21st, at Killearn Lakes United Methodist Church. There were many items on the agenda, including the 2019 budget, pool pavilion and complex updates, and prospective bidding out of our of lawn and pool services. Big thanks to our volunteer Treasurer Traci Wharton for all her hard work throughout the year and on this year's budget preparation. Our 2019 projected revenue is \$30,100.00 with expenses projected to total \$26,447.00. The cost of the pavilion is not included as part of the fixed budget and is being

paid from savings. 1/3 (\$9,000.00) of the cost of the pavilion was paid in 2018 with the remainder due upon completion. Current Liquid Assets as of 1/21/2019:

Savings:

\$31,808.95

Checking:

\$20,774.83

\$52,583.78

Also at the meeting, residents and board members discussed covenant breaches and enforcement. The biggest issues continue to be mildewed siding, service or branded vehicles being parked overnight and unkempt lawns. Killearn Commons is a covenant restricted community. Residents who have

- mildew on their siding.
- park on their lawn or sidewalk,
- have non-conforming mailboxes,
- park trailers, RVs or commercial vehicles in driveway OR street
- <u>neglected lawn or property care</u> will be receiving a notice of their violation(s).

Recipients will have **45 days** to rectify the violation or face fines by the Association. # **Pool Cabana Reservation** Agreement (up to 4 hours)

- 1. User must be a resident of Killearn Commons
- 2. User agrees to abide by all pool rules posted (No smoking, No glass bottles or plates,

no rough play, etc.).

- 3. User agrees to pay for all damages to the facility, grounds and property, and for any other charges that may be incurred.
- 4. User is responsible for removal of all personal articles, including leftover food, beverage containers, spent charcoal and decorations. Grill shall be cleaned after use.
- 5. No pets or animals (except service dogs) are permitted in the complex.
- 6. User agrees to monitor gate to admit and release non-resident quests.
- 7. This reservation is for caban and grill area only. The pool facility will remain open to

all residents.

8. There is a \$50 non-refundable reservation fee. Fee MUST be paid prior to event time.
